TERMS AND CONDITIONS

LIMITED LIFETIME COVERAGE: This Limited Warranty extends only to a purchaser of WeatherLok Metal Roofing stone-coated steel panels who has paid for the WeatherLok Metal Roofing Product in full and provides proof of purchase (the "Purchaser") and to subsequent owners of the property to which the WeatherLok Metal Roofing Product is originally affixed, after purchase (the "Property"). Subject to the terms, conditions and limitations herein, WeatherLok Metal Roofing hereby warrants that for the lifetime of Purchaser during Purchaser's ownership of the Property or, if the Property is transferred by Purchaser, for fifty (50) years from the date of installation of the WeatherLok Metal Roofing Products, the WeatherLok Metal Roofing Products will be free from manufacturing defects in workmanship and materials such that:

- Each WeatherLok Metal Roofing Product (meaning each individual WeatherLok Metal Roofing panel) will withstand winds of up to 110 miles per hour;
- Steel substrate on WeatherLok Metal Roofing Products will not burn and steel substrate will not be penetrated all the way through by hailstones less than two inches (2") in diameter such that the WeatherLok Metal Roofing Products are no longer waterproof;
- The appearance of the surface coating of WeatherLok Metal Roofing Products will not materially deteriorate beyond normal weathering and aging, including minor granule loss over the extended life of the warranty.

EXCLUSIVE REMEDY: In the event any WeatherLok Metal Roofing Product fails to meet the above standards, WeatherLok Metal Roofing will either provide repairs to the WeatherLok Metal Roofing Product, or will provide replacement products and labor at WeatherLok Metal Roofing's option and at its sole discretion. WeatherLok Metal Roofing reserves the right to require you to pay its reasonable costs and expenses incurred in performing any physical inspection of WeatherLok Metal Roofing Products that are subject to a warranty claim, although any such payment will be refunded in the event of a valid warranty claim. Any repair or replacement by WeatherLok Metal Roofing shall not extend the term of this warranty except as required by law or as agreed in writing by WeatherLok Metal Roofing. This is the sole and exclusive remedy under this Limited Warranty, and in no event shall WeatherLok Metal Roofing have any liability for any consequential, incidental, economic, indirect, special or punitive damages or losses of any kind whatsoever. (Advisory: some states do not allow the exclusion or limitation of incidental or consequential damages). **NO OTHER WARRANTIES:** This Limited Warranty is the only warranty given by WeatherLok Metal Roofing, and no other warranties of any kind have been made with respect to the WeatherLok Metal Roofing Products. (Advisory: some laws do not allow limitations on certain implied warranties). This warranty gives you specific legal rights, and you may have other rights which vary from state to state.

CLAIMS PROCEDURE: If you experience a problem with a WeatherLok Metal Roofing Product that you believe is covered by this Limited Warranty, please contact us promptly via phone at (920) 782-7577, or via e-mail to info@weatherlokroofing.com and provide us with your name, address, telephone number, your proof of purchase, and a specific detailed description of the defect or problem, as well as any other information or materials you believe is relevant. You may be required to provide additional information or materials at the request of WeatherLok Metal Roofing, including photographs. As a condition of coverage under this Limited Warranty, you must notify us of any problem or defect within thirty (30) days after you discover or reasonably should have discovered it.

OTHER TERMS, CONDITIONS, DISCLOSURES AND LIMITATIONS:

1. While we expressly warrant that the WeatherLok Metal Roofing Products are free from manufacturing defects as set forth above, the performance of your WeatherLok Metal Roofing Product is largely dependent on the manner in which it is installed and cared for. Consequently, this Limited Warranty shall not apply to any of the following circumstances:
 - Damage caused by improper installation, or the installer's failure to follow WeatherLok Metal Roofing's installation standards and instructions, or reasonable professional installation procedures. We recommend that you ask your installer or contractor about warranties covering installation, as WeatherLok Metal Roofing does not in any way warrant or guarantee such services. We recommend that you have roofing products installed by a professional who has attended manufacturer training courses, although such training is neither required for this warranty nor a guarantee of proper installation.
 - WeatherLok Metal Roofing Products that have been damaged, modified, altered or changed in design or function after shipping from WeatherLok Metal Roofing's facility, or used or installed for a purpose other than roofing.
 - Damage or change in appearance caused by any of the following: foot traffic or foreign objects, climate-specific conditions (such as mold or mildew from moisture or humidity), the application of cleaning fluids, coatings or chemicals not specifically approved and authorized by WeatherLok Metal Roofing, or the failure or movement of the structure of the Property on which the WeatherLok Metal Roofing Products are installed.
2. Dealers, distributors and installers of WeatherLok Metal Roofing Products are independent contractors and not agents of WeatherLok Metal Roofing for any purpose, and are not authorized to extend other warranties on behalf of WeatherLok Metal Roofing, or to modify the terms of this Limited Warranty in any manner.
3. This Limited Warranty shall be void in the event of repairs or modifications made by any person to the WeatherLok Metal Roofing Products that are not first approved in writing by WeatherLok Metal Roofing, except necessary temporary emergency repairs.
4. If any provision of these Terms and Conditions is held by a court of competent jurisdiction to be invalid, void or unenforceable, the remaining provisions shall nevertheless continue in full force and effect.
